- Supervises and mentors Slickline Assistants and completes job evaluations.
- Provides assistance to the Slickline Assistants in some aspects of rigging up and down of equipment. •
- Operates Slickline unit performing down-hole work until job is completed for day.
- Checks all equipment to make sure it is secured and put away.
- Completes all field tickets and forwards to appropriate processing office in a timely manner.
